Rules for Entry - Artist Copy

ENTRY FORM DEADLINE: Friday, November 1st by 11:59 pm

Forms can be sent to info@tuolumnecountyarts.org or delivered in person to 21 N. Washington St. **Artists must also submit 1-2 images of their entry via email.** Artists submitting multiple entries should complete separate entry forms for each piece.

ART DROP-OFF DEADLINE: November 2nd-5th

Entries must be delivered to TCA at 21 N. Washington St, Sonora, CA from 11/2-11/5 between 11:00am to 6:00pm.

Please contact us for mailing info. Due to the fragile nature of miniatures we cannot accept 3D via mail. For special delivery/pick up arrangements email us at info@tuolumnecountyarts.org.

Submission Requirements:

- **2D** pieces may be up to, but **no larger than 7"x7"** including the frame (*if you choose to use one*). **All 2-dimensional art must be ready to hang with wire attachments.** Matted images without a frame will not be accepted.
- **3D** pieces may be up to, but **no larger than 7"x7"x9"** including the base.
- Digital creations must be submitted in a physical format (*example: photography or digital art can be submitted as prints*).
- All entries must be original and not a copy of anyone else's work or photograph.

Note: It is possible not all entries will be accepted if they cannot be easily displayed.

Show Details:

The 2024 Small Works Show will be open and on display at the Sonora Chamber of Commerce (47 N. Washington St, Sonora, CA) from **November 9th through December 14th, with an opening reception Saturday, November 9th from 5:30-8:00pm. Bidding will also be open from November 9th through December 14th.** Throughout the week of 12/15-12/21 remaining works will stay on display while winning bidders and artists claiming unsold works pick up their pieces. Please check our website for any updates or changes or feel free to contact us for additional questions.

Rules for Entry - Artist Copy

Sales, Pricing, & Bidding:

All entries are considered donations to TCA and will be available for sale at the Small Works Show through a silent auction format. All proceeds from the show will go towards Tuolumne County Arts' operational costs.

Artists decide the value price of their own submissions, the minimum being \$30. Starting bids for each piece will then be set at half its value price (*example: if the artwork is valued at \$50 the minimum bid will be set at \$25*). Bids may be placed via email or in person from 11/9–12/14. Bidding increases will be in increments of \$10 (or more) and will be updated daily at www.mytuolumnecountyarts.org/smallworksshow.

Unsold works: In the event that any works remain unsold after bidding ends, the artists will be contacted by TCA. Artists who would like their unsold work(s) returned to them will **need to claim and pick-up their piece(s) between 12/17–12/23** or arrange an alternative pick-up time. If you do not claim/pick-up your unsold work and do not make alternate pick-up arrangements it will remain the property of TCA to display, sell, or give away at our discretion.

Rewards for Entry:

Most importantly, a HUGE thank you for helping us raise money to keep TCA going! Your support is what allows us to continue providing arts resources to the community. But you will also receive:

- **Gift Certificate:** A one-time \$10 certificate to spend at our REVAMP Creative Reuse Shop where you can buy discounted arts & crafts supplies and more.
- **Membership:** You will receive one annual membership to TCA. This includes, but is not limited to:
 - Free entry to monthly Open Art Fridays at our workspace.
 - Guaranteed entry into our membership show & sale in June 2025. This show will NOT have small size restrictions for pieces, and 100% of the sales will go through and to the artists.
- **Artist Feature:** If possible, your artwork and artist info will be displayed on our social media (Facebook & Instagram) and/or our website!

Artist Agreement

Submission Requirements:

- **2D** pieces may be up to, but **no larger than 7"x7"** including the frame (if you choose to use one). **All 2-dimensional art must be ready to hang with wire attachments.** Matted images without a frame will not be accepted.
- **3D** pieces may be up to, but **no larger than 7"x7"x9"** including the base.
- Digital creations must be submitted in a physical format (*example: photography or digital art can be submitted as prints*).
- All entries must be original and not a copy of anyone else's work or photograph.

Note: It is possible not all entries will be accepted if they cannot be easily displayed.

Delivery information:

Entries must be delivered to TCA at 21 N. Washington St, Sonora, CA from 11/2-11/5 between 11:00am to 6:00pm.

Tuolumne County Arts will not be held liable for any damages to the artwork arising from mounting, preparation, presentation and transportation or other reasonable activities. Artist further agrees to release and to hold harmless the Gallery, its officers, directors, employees, volunteers, and agents from any and all loss, liability, claim, or expense which the Gallery may incur or to which they may be put, as a result of or, in connection with a Gallery show.
